

## STUDENT VISA

Applicants should have the following for the Visa Appointment at the Spanish Embassy:

- 1) Duly completed dated and signed **Application Form** (*available on our web*)
- 2) Original **passport** valid for at least **two** years from the date of application **plus photocopies** (Picture page and renewal in case of renewed passport). If you wish to apply with a EU passport, you must provide also Lebanese Passport or a Lebanese ID or Civil Register ("EKHRAJ KAID FARDE"), *Translated into Spanish and legalised by the Lebanese Ministry of Foreign Affairs*
- 3) Photocopies of **previous visas** (Schengen, USA, UK and Canada)
- 4) One recent passport **photograph** with a white background, frontal view (3,5 x 4,5 cm).
- 5) Visa **fees**: Around 132.000 L.L.
- 6) **Acceptance Letter** from FTE Jerez  
*Sent directly by them and in Spanish*
- 7) **Medical insurance** provide by FTE Jerez and valid for the whole period of stay in Spain  
*Sent directly by them and in Spanish*
- 8) **Stamped Letter from Middle East Airlines**  
*Translated into Spanish (no need for legislation)*
- 9) **Police Certificate** ("SEJEL AADLEH / LA HOKM AALE")  
*Translated into Spanish and legalised by the Lebanese or applicable Ministry of Foreign Affairs (both the original and the translation)*  
Issued by the authorities of the country of origin and the country and countries where the person has been residing for the last five years (if applicable)  
This certificate must show that the person has not been sentenced for offences included in the Spanish Penal Code. This document should have a maximum validity of three months since its issue date.
- 10) **Medical Certificate**  
*Translated into Spanish and legalised by the Lebanese or Applicable Ministry of Foreign Affairs (both the original and the translation)*. This document should have a maximum validity of three months since its issue date.
- 11) **Diplomas**  
*Translated into Spanish by a juror translator.*

**ALL PREVIOUS DOCUMENTS MUST BE SUBMITTED IN ORIGINAL PLUS ONE COPY**

**THE POLICE CERTIFICATES AND THE MEDICAL CERTIFICATE SHOULD BE ALSO LEGALISED BY THE EMBASSY OF SPAIN LOCATED IN THE COUNTRY WHERE THEY WERE ISSUED.**

The process for a student visa will take around two to three weeks to resolve starting the date of submission of the application at the Embassy of Spain in Hadath-Baabda between 9am and 10am.

You may keep the passport after applying for the visa if you wish to.
